

HORIZONTAL EXHAUST INSTALLATION ONLY (CONT'D)

6. Reinstall and secure the faceplate on the unit by securing the faceplate to the unit using its 4 retaining screws (two per side, circled in FIG. 28). Plug the blower cable to its connector on faceplate (FIG. 28).



CONNECT DUCTWORK

VERTICAL EXHAUST INSTALLATION ONLY


Ducted Installation

Use 6-in. round or $3\frac{1}{4}$ " x 10" metal duct to connect the adapter damper on the top of the unit to the ductwork above (FIG. 29). Seal the joint using aluminum duct tape.

Non-Ducted Installation

A non-duct kit is required for this type of installation (purchase separately). To install, follow the instructions packed with the kit. Refer to table below to find the appropriate non-duct kit according to the unit.

WIRING

A WARNING

Risk of electric shock. Electrical wiring must be done by qualified personnel in accordance with all applicable codes and standards. Before connecting wires, switch power off at service panel and lock service disconnecting means to prevent power from being switched on accidentally.

- 1. Using appropriate wire nuts (not included), connect house power cable to unit wiring: BLACK to BLACK, WHITE to WHITE and GREEN or bare wire to GREEN ground screw (FIG. 30).
- 2. Reinstall the electrical cover in the unit; ensuring the bottom tabs are inserted in their embossed location. Secure in place using its retaining screw (FIG. 31).


Ducted Installation


Reinstall the grease filter(s).

Non-Ducted Installation

PM400SS unit only: Attach the non-ducted filter (included with the HARKPM21 non-duct kit) to the back of the grease filter using clips (provided with non-ducted filter). To order a new non-ducted filter, use service part number S99010464.

BBN2243SS and BBN2303SS units only: Attach the non-ducted filters (included with the HARKBN24 or HARKBN30 non-duct kit) to the back of the grease filters using clips (provided with non-ducted filter). To order new non-ducted filters, use service part number S99010464-124 for BBN2243SS and S99010464-130 for BBN2303SS model.





OPERATION

PM400SS

Blower Switch:

A rotary 4-position knob controls the blower speed (Off - low speed - medium speed - high speed).

Light Switch:

A rotary 2-position knob turns the LED lights ON and OFF.

NOTE: If there is no speed selected (all blower speed push buttons up), the blower will not turn ON. In that case, press on the desired speed level push button to activate the blower.





Blower Speed Level Push Buttons:

When blower is ON, change the blower speed by pressing the push button corresponding to the desired speed: one line for LOW, two lines for MEDIUM and three lines for HIGH speed.

ON/OFF Light Push Button: When lights are OFF, push once on this button to turn ON the lights. Push this button again to turn OFF the lights.

ALL UNITS

HEAT SENTRY™


Your unit is equipped with a HEAT SENTRY™ thermostat. This thermostat is a device that will turn on or speed up the blower if it senses excessive heat above the cooking surface.

- 1) If blower is OFF it turns blower ON to HIGH speed.
- 2) If blower is ON at a lower speed setting it turns blower up to HIGH speed.

When the temperature level drops to normal, the blower will return to its original setting.

WARNING

The HEAT SENTRY thermostat can start the blower even if the hood is turned OFF. When this occurs, it is impossible to turn the blower OFF with its switch. If you must stop the blower, set the main power switch (located behind the filters, on inner side of the unit faceplate) in OFF position (if it is possible to do so safely). See inset in FIG. 32.





MAINTENANCE

ALWAYS SWITCH OFF THE ELECTRICITY SUPPLY BEFORE CARRYING OUT ANY OPERATIONS ON THE APPLIANCE.

Grease Filter(s)

The grease filter(s) should be cleaned frequently. Use a warm dishwashing detergent solution. Grease filter(s) is (are) dishwasher safe.

Clean the filter(s) in the dishwasher using a non-phosphate detergent. Discoloration of the filter(s) may occur if using phosphate detergents, or as a result of local water conditions - but this will not affect filter performance. This discoloration is not covered by the warranty. To minimize or prevent discoloration, hand wash filter(s) using a mild detergent.

Non-Ducted Recirculation Filter(s)

The Non-Ducted Recirculation filter(s) should be changed every 3 to 6 months. Replace more often if your cooking style generates extra grease, such as frying and wok cooking.

STAINLESS STEEL CLEANING

Do:

- Regularly wash with clean cloth or rag soaked with warm water and mild soap or liquid dish detergent.
- Always clean in the direction of original polish lines.
- Always rinse well with clear water (2 or 3 times) after cleaning. Wipe dry completely.
- You may also use a specialized household stainless steel cleaner.

Don't:


- Use any steel or stainless steel wool or any other scrapers to remove stubborn dirt.
- Use any harsh or abrasive cleansers.
- Allow dirt to accumulate.
- Let plaster dust or any other construction residues reach the unit. During construction/ renovation, cover the unit to make sure no dust sticks to the stainless steel surface.

Avoid when choosing a detergent:

- Any cleaners that contain bleach will attack stainless steel.
- Any products containing: chloride, fluoride, iodide, bromide will deteriorate surfaces rapidly.
- Any combustible products used for cleaning such as acetone, alcohol, ether, benzol, etc., are highly explosive and should never be used close to a range.





Limited Warranty

Warranty Period and Exclusions: Broan-NuTone LLC and Venmar Ventilation ULC (either being the "Company") warrants to the original consumer purchaser of its product ("you") that the product (the "Product") will be free from material defects in the Product or its workmanship for a period of one (1) year from the date of original purchase (or such longer period as may be required by applicable law). For Range Hood Product that includes built-in LED modules, the Company warrants the LED modules and driver to be free from material defects for a period of three (3) years from the date of purchase. The limited warranty period for any replacement parts provided by the Company and for any Products repaired or replaced under this limited warranty shall be the remainder of the original warranty period (or such longer period as may be required by applicable law).

This warranty does not cover fluorescent lamp starters, tubes, halogen, incandescent and LED bulbs, fuses, filters, ducts, roof caps, wall caps and other accessories for ducting that may be purchased separately and installed with the Product. No Other Warranties: This Limited Warranty contains the Company's sole obligation and your sole remedy for defective products. The foregoing warranties are exclusive and in lieu of any other warranties and conditions, express or implied. THE COMPANY DISCLAIMS AND EXCLUDES ALL OTHER EXPRESS WARRANTIES AND CONDITIONS, AND DISCLAIMS AND EXCLUDES ALL WARRANTIES AND CONDITIONS IMPLIED BY LAW, INCLUDING WITHOUT LIMITATION THOSE OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
